



AGREEMENT FOR DISPOSAL SERVICES

between

American Disposal Services and the Canterbury Woods Civic Association

March 31, 2005

American Disposal Services (ADS) agrees to the following:

1. Period of Agreement: June 1, 2005 through May 31, 2009, or four years in duration.
2. ADS provides the residents of the Canterbury Woods Civic Association (CWCA) same day (Wednesday) collection service for trash, recyclables, and yard waste for once-per-week service. Friday is the second day for twice-per-week trash service.
3. **BASE RATES:**
 - a. \$62.85 per quarter (\$20.95/month) for **ONCE-PER-WEEK SERVICE**
 - b. \$70.35 per quarter (\$23.45/month) **FOR TWO TOTERS, ONCE-PER-WEEK SERVICE**
 - c. \$80.82 per quarter (\$26.94/month) for **TWICE-PER-WEEK SERVICE**
4. **INCENTIVE RATE FOR FIRST 250 HOMES TO SIGN UP:**
 - a. \$60.60 per quarter (\$20.20/month) for **ONCE-PER-WEEK SERVICE**
 - b. \$67.83 per quarter (\$22.61/month) **FOR TWO TOTERS, ONCE-PER-WEEK SERVICE**
 - c. \$77.96 per quarter (\$25.99/month) for **TWICE-PER-WEEK SERVICE**
5. **INCENTIVE RATE FOR ALL CWCA RESIDENTS IF MORE THAN 250 HOMES SIGN-UP IN THE FIRST QUARTER OF SERVICE:**
 - a. \$57.60 per quarter (\$19.20/month) for **ONCE-PER-WEEK SERVICE**
 - b. \$64.47 per quarter (\$21.49/month) **FOR TWO TOTERS, ONCE-PER-WEEK SERVICE**
 - c. \$74.10 per quarter (\$24.70/month) for **TWICE-PER-WEEK SERVICE**
6. Bulk pick-up for an extra-large trash or yard waste collection is included in the rates listed above, within reason. White goods such as large household appliances like refrigerators, stoves, washers, etc. are excluded. Resident must contact ADS Customer Service at 703-368-0500 at least 24 hours in advance to schedule a bulk pick-up.

7. ADS is responsible for all contract administration with the individual CWCA residents. The CWCA Executive Committee will provide a listing of all 517 CWCA residents with house numbers and street addresses to ADS. Each CWCA resident must individually contact ADS (by phone at 703-368-0500 or FAX or mail) to start trash service with ADS and identify himself or herself as a "CWCA resident" to take advantage of the "CWCA-Recommended Trash Service" rates.

8. ADS will provide a 96-gallon trash toter and two 18-gallon recycling containers, or similar sized toter and containers, to each CWCA resident within two weeks of signing up for ADS service.

9. ADS will provide make-up collections on the next scheduled service day for collections canceled for Holidays (Thanksgiving, Christmas, and New Year's Day) and/or hazardous-weather days when collection cannot be made. Scheduled trash collections days are on Wednesday and Friday. The recyclables and yard waste collection day is only on Wednesday.


10. The CWCA will publish the contact information for ADS as the "CWCA-Recommended Trash Service" in each *CWCA Gazette*, the CWCA community newsletter, and on the CWCA website for the duration of this agreement.

11. ADS will provide collection service "from the carport" for elderly and handicapped residents for a specified period, at no additional cost, upon approval by the CWCA Executive Committee and notification to ADS.

12. ADS will periodically (minimum of twice per year) provide information on bulk pick-ups, acceptable recyclable items, procedures and limitations for yard waste, Christmas tree pick-ups, and Fairfax County Household Hazardous Waste procedures. ADS can use the *CWCA Gazette*, at no cost, to communicate recycling information and "trash tips" to the CWCA residents.

13. All Fairfax County tipping fee and three (2006, 2007, and 2008) annual Consumer Price Index increases (established by a local government, but not to exceed 3.0 percent per year) will be applied to the ADS rates after consulting the CWCA Executive Committee.

14. ADS will provide a representative at the CWCA Annual Spring Meeting and at the CWCA Executive Committee meetings when ADS rate increases are requested.
